By clicking on the acceptance check-box and submitting your application form you agree to the following terms and conditions, so please read them carefully first.

### **Definitions**

We use the following definitions:

- 1. "Your Contact Details" means your street address, email address and phone number together with the email address, if supplied, of the originator
- 2. "The Cultivar Details" means all other details relating to this application, as entered on the form and subsequently updated and supplemented. These include details of the Cultivar itself, any photographs supplied, the name of the originator and your name, city, state (or equivalent) and country.
- 3. "Selected Details" means the Cultivar Details in whole or part
- 4. "Register" means an official list of Passiflora cultivars prepared and maintained by the Registrar, his predecessors and successors
- 5. "The Cultivar" means the Passiflora cultivar which is the subject of this application and of which details are given on the form
- 6. "Third Party Services" means such website hosting, search engine, automated application form and other facilities as are used by us and supplied by firms such as Google, Jotform and Facebook.
- 7. ## Your submission and the procedure thereafter

In submitting this form:

We will acknowledge your application immediately and then aim to respond substantively within a few months either with immediate confirmation of registration or with a few queries.

Assuming any such queries are answered satisfactorily, we will then aim to publish your Cultivar Details in the next issue of the register, or the next but one if you miss the deadline. We aim to issue a new register every two years. Prior to such publication we will not divulge them to any third party without your prior permission. In the event that you update your information, we will incorporate your changes accurately and as and when appropriate once you have notified us as described above.

We will not knowingly divulge your Contact Details to any third party at any time without first seeking your prior approval.

### **Security**
